

## STATEMENT PURSUANT TO THE REGULATIONS ON PERSONAL DATA PROTECTION.

This Statement is made pursuant to and in accordance with Art. 13 of Regulation (EU) 2016/679 (hereinafter “GDPR”) on the protection of natural persons with regard to the processing of their personal data.

This website (hereinafter the “Website”) and all the services that are provided here (hereinafter the “Services”) are not intended for under 16s and Metalco S.r.l., in its capacity as data controller (hereinafter the “Company” or “Data Controller”), does not intentionally collect the personal data of minors. Should information regarding minors be recorded involuntarily, the Data Controller will cancel such information promptly upon users’ request.

### **Legal basis and purpose of processing**

Your personal data are processed:

A) without your express consent, for the following purposes related to the Services/use of the Website:

- to manage and maintain the Website;
- to enable you to use the Services you have requested;
- to process a contact request;
- to fulfil the obligations laid down by the law, by a regulation, by EU legislation or by an order issued by the Supervisory Authority;
- to prevent or discover fraudulent activities or abuse that are damaging to the Website;
- to exercise the rights of the Data Controller;

in relation to these purposes, your consent is not required because the data processing is necessary in order to provide the Services or to fulfil a legal obligation;

B) only subject to your specific and separate consent, for the following other purposes:

- to email you opinion polls or satisfaction surveys, newsletters and/or invitations or to sign you up for events in which the Data Controller is taking part or is the organiser (hereinafter “Marketing”);

### **Data storage period**

Your personal data will be processed for the time strictly necessary in order to pursue the above purposes, after such time the data will be deleted or made anonymous.

Specifically as regards the purposes described in point B), your personal data will be processed for 24 months with reference to the Marketing purposes, except where you withdraw your consent, which could concern one, some or all of such purposes.

### **Providing your data and the consequences of refusing to do so**

Providing your data for the purposes described in point A) is necessary in order to register on the Website and to use the services offered.

Providing your data for the purposes described in point B) is optional. Therefore, you may decide not to provide any data or to later object to the processing of the data provided. In this case you will not receive any emails inviting you to events, newsletters, opinion polls or satisfaction surveys and, above all, you will not receive any information regarding initiatives that are tailored to your preferences. You will continue to receive the services referred to in point A).

### **Data disclosure and categories of recipients**

Your data may be disclosed:

- for the purposes referred to in Point A), to the Data Controller’s employees and consultants, in their capacity as persons authorised to carry out processing and/or system administrators;
- for the purposes referred to in Point B), to third party company or other entities (e.g. web agencies) that perform outsourcing activities on behalf of the Data Controller in their capacity as data processors;

where your data have to be processed by third parties on behalf of the Company, these third parties will be designated as data processors under an appropriate contract or other legal document; in any case, your data will not be disclosed by them.

### **Transfer of data to a third country and/or international organisation**

Your personal data will not be transferred to third countries outside the EU.

### **Rights of data subjects**

You have the right (see articles 15 -22 of the GDPR) to request our Company for access to your personal data and to rectify them if they are inaccurate, delete them or restrict processing, and to obtain portability of the data provided by you only if subject to automated processing based on your consent or on a contract.

You also have the right to withdraw the consent given for the processing purposes that require it without affecting the lawfulness of processing based on consent before its withdrawal.

You also have the right to lodge a complaint with the competent authority (Italian Data Protection Authority).
